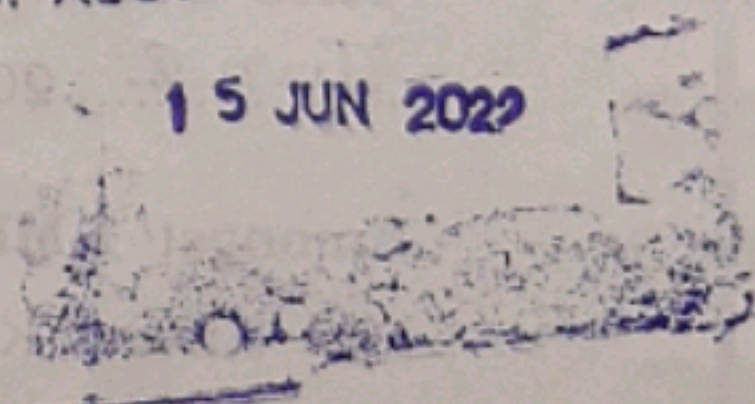

WHEREAS the settler has desired to establish a Non Profitable, Non Political & Non Commercial **PUBLIC CHARITABLE TRUST** in the registered address of the trust for various public charitable purpose as are specified in objective clause mentioned herein below.

AND WHEREAS to fulfill the said desire the settler has set apart a sum of Rs. 10,000/- for initiation of the said Non Profitable, Non Political & Non Commercial **PUBLIC CHARITABLE TRUST** to be held by the Trustees as corpus Fund of the Trust.

Purpose) Colleges, Universities, Madrasa and other Educational Institutions, Scientific, Commercial, Industrial, Technical and Vocational Institutions, Coaching Centers, Primary Teacher Training Institutions, B.Ed. College, B.P. Ed. Colleges, Engineering Colleges, Management Colleges, Competitive Training Institute for various competitive Examination such as PSC, UPSC and SSC, etc. Other job Oriented Training, Computer Training including Certificate and Diploma course, beautician training including Certificate and Diploma course and do all the things that are necessary for establishment, management and promotion of up the managements of such institutions established by any similar Trust or Association registered under the Societies Registration Act or any other enactments in force or that may be brought into force by the State or Central Government.

- (iii) To open, found, establish, promote, set up, run, maintain, assist, support and or aid or help in the setting up or maintain and play School, Stadiums, Playground and Parks for the use of Public, sports and games.
- (iv) To give, provide or render food, medicine and other help and or assistance in any shape or form to the poor, deserving the needy persons. To organize any type of Fair, to give stall in any fair, to encourage the Handicapped through different social welfare programmers.
- (v) To Development and Welfare of Farmer, Backward Classes, Lab our, Agricultural Labour, Weavers, Workers, Weaker section of the society and Campaigning and promoting, Products and Artisans by providing practical Skill Development Training Programme in the latest technology through work experience and other management practices.
- (vi) To work in the field of Women Empowerment, Women welfare programme, Livelihood supports to the Self Help Groups (SHGs), Attend every village / Urban Fair and campaign the product of various Handicraft Items produced by Self Help Groups & inspire and supports of the Self Help Group (SHGs) and training programme of Handicrafts Items.
- (vii) To establish conduct, maintain, run and manage Hospitals, Nursing Homes, Charitable Dispensaries, Laboratories and Diagnostic Centers, Health Care Centers, etc. for the benefit of general public.
- (viii) To establish, maintain and run, Libraries, Reading Rooms, Hostels, Laboratories, Sports Compound, Gymnasiums Hall, Auditorium, Park,

AND WHEREAS at the request of the **SETTLOR**, the **TRUSTEES** herein have also agreed to sign their acceptance by joining in the execution of this DEED OF TRUST along with the settler.

AND WHEREAS the **SETTLOR** has already handed over a sum of Rs. 10,000/- (Rupees Ten Thousand Only) to the **TRUSTEES** to be held by them as Corpus Fund with power to receive contributions, donations, subscriptions, grants, settlements, loans or financial institutions, trusts, societies, corporate bodies, etc. or from any corner for the purpose of fulfillment of the objectives of **THIS** Non Profitable, Non Political & Non Commercial **PUBLIC CHARITABLE TRUST**.

AND WHEREAS the Settlers and Trustees of the Trust is interested in promoting and rendering regular, distance and open education (primary, secondary and higher secondary, higher education, computer education and all type of equivalent educations) to the economic low income group, school dropout boys and girls of the native state and others who wants to continue their studies and bears interest in doing continue education from the private body as such also the trust is subjected to provide the certification after the successful completion of the study tour and examination which is conducted by this thrust thereof.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

That the said "**SETTLOR**" having already over, transferred, assigned and given to the trustees herein a sum of Rs. **10,000/- (Rupees Ten Thousand Only)** upon trust along with all future conditions as contained hereinafter and further the trustees are authorized to take and receive and accept funds from other person or persons including relatives, friends and well-wishers of the trustees and also from any firms, companies, banks, financial institutions, trusts, societies, corporate bodies or from any corner any amount for being added to the Corpus Fund by way of contributions, donations, subscriptions, grants, settlements, loans or financial, assistance for carrying out and / or performing any one or more of the objectives for which this trust has been created and established and may send funds on such terms and conditions as may be resolved on majority of votes amongst the trustees from time to time in fulfillment of the Non Profitable, Non Political & Non Commercial **PUBLIC CHARITABLE OBJECTIVES OF THE TRUST**.

Trust Property: At Present the trust has no immovable and landed property save and except the Trust Value amounting Rs. 10000/- in it's own name

and no immovable and landed property is being settled in favour of this trust by this document.

Whereas The Settler Is Desirous Off Establishing In Perpetuity A Fund Amounting Rs.10000/- In India For Charitable Purpose Including Relief To The Poor, Education, Medical Relief And Advancement Of Any Other Object Of General Public Utility Not Involving Or Carrying On Of Any Activity For Profit All Over India And For This He Is Desirous Of Setting Up A Public Charitable Trust For The Advancement Of The Said Charitable Objects Only In India And Whereas The Trustees As Above, At The Request Of The Settler, Have Given Their consent To Act as The Trustees Along With The Settler For Administration Of The Affairs Of The Trust In Accordance With The Terms And The Conditions Hereafter Provided.

1) NAME:

The name of the trust shall be *Non Profitable, Non Political & Non Commercial Public Charitable Trust* " **ROLL BALL SPORTS FEDERATION** " hereinafter referred to as the said "**TRUST**". It is a non-political, educational, cultural religious and social welfare organization for charitable purpose to develop spiritualism as well as humanitarian attitude in mankind.

2) REGISTERED RENTED

OFFICE:

The registered office of the trust is situated at **C67 HINDPARK , BANDIPUR SAIBON ROAD P.O.- RAHARA P.S.- RAHARA DIST- NORTH 24 PGS PIN.- 700118 WEST BENGAL FOR OFFICIAL CORRESPONDANCE ONLY AND IT IS NOT THE TRUST PROPERTY.**

By a majority of votes, the trustees may shift the registered office to any other place or to open its branches to any other places as they decide within India.

2(A) Trust Property: At Present the trust has no immovable and landed it's own name and no immovable and landed property is being settled in favour of this trust by this document.

3) No Immovable Property Belongs To The Trust Shall Be Sold, Exchanged, Transferred, Converted, Mortgaged Or Alienated In Any Manner Whatsoever Except When Such Exchange, Transfer, Conversion Or Alienation:

**Is Imperative In The Interest Of The Trust And Institutions And Department Connected Therewith,
Is Not Likely To Adversely Affect To Any Extent Whatsoever The Existence And Benefit Of The Trust, Institution And Departments Connected Therewith An Object Of Thee Trust, And
Is Decided To That Effect By The Board In Its Meeting By A Resolution Passed By Majority Of The Trustees Present.**

4) FUND OF THE TRUST:

The Corpus Fund, loan fund and the assets together with all further donation, contributions and accretions in any shape or form made to and / or receive by the trust from time to time and the rents, surplus of fund and income thereof and the stocks, funds, representing the same shall be held by the trustees upon trust for the objects and purpose and subject to the power and provisions hereinafter set out.

5) OBJECTIVES:

The objectives, for which the trust is created, are as follows:-

Trust Property: At Present the trust has no immovable and landed it's own name and no immovable and landed property is being settled in favour of this trust by this document.

- (i) **That the aims and objectives of the trust shall be of general public welfare and other charitable purpose including relief of the poor, education, medical relief and advancement of any object of public utility not involving the carrying on of any activity for profits as defined under the income tax act, 1961 and/ or under any order for the time being in force under the income tax act and / or any stationery modifications thereof. Besides such objectives in general the trust will be worked with the main aims and objects for which this trust is established and which are clearly mention in the above said clause 3.**
- (ii) **To Promote education and culture by establishing and managing educational institution like Nursery and Primary Schools, Secondary and Higher Secondary Schools, ITI Course, Teachers Training Programme ,Computer Education, Nursing And Paramedical Course(For Consultancy**

Guest Room, Old Aged Homes for men and women, Orphanage Houses, etc. for fulfillment of the Charitable objectives of the trust.

- (ix) To establish forums and centers and arrange to render services and to provide help to establish units the Scheme of SSI (Small Scale Industries).
- (x) To help, guide, train up, meritorious students, interested people irrespective of caste, creed and communities in different fields.
- (xi) To organize seminars, symposia, lectures, debates, legal awareness camp, environment awareness camps, cultural functions, celebrations, etc. for the purpose of fulfillment of the objectives of the trust;
- (xii) To print, publish, preach, purchase, sale and distribute pamphlets, reports, proceedings, bulletins, journals, magazines, periodicals, books, etc. for the promotion of the objects;
- (xiii) To realize rent or revenues from any lands, buildings, properties of the trust;
- (xiv) To establish, conduct, maintain and institutions for promotion of Fine Arts, Tape Libraries, both Audio and Video like for the benefit of general people.
- (xv) To promote co-operation and co-ordination in the field of education, economy and culture among all Community of the Country.
- (xvi) To provide shelter, food, care, guidance, protection, medical aid and education to boys and girls coming from different parts of the Country.
- (xvii) To establish forums and centers and arrange or render service to the old and incapacitated and medical relief and charity to the poor, needy and deserving people.
- (xviii) To help, guide, train up meritorious students, preferably of Economically Backward Community in different competitive examinations;
- (xix) To subscribe and or become a member of co-operatives or any other associations, organization, Societies or Bodies objectives of which are similar to those of the trust;
- (xx) To arrange for life cycle needs of the weaker and backward section of the community in the urban and semi urban and rural society such as wedding, funerals, child birth, education, home building, widow-hood, old age etc;
- (xxi) To take legal action against any person or organization for the cause which might arise at different times and also to defend and to take all necessary steps for any action by any person or organization against this

trust or any member of the board of trustees or member of the Board of Trust in their official capacity.

- (xxii) Moreover, to do or undertake any or all acts of charity incidental or necessary to the attainment of the above object or objects.
- (xxiii) To assist, finance, support for establishment and maintenance of an institution meant for grant of relief to the poor section of the public, advancement of education including relief and moral appointment of the masses.
- (xxiv) To open establish or contribute to the maintenance of orphanages, widows, orphan houses, poor houses and other institutions for the welfare of orphans and widows / or disabled persons.
- (xxv) To render medical help, assistance to needy persons and to arrange for treatment of such persons by providing Allopathic. Homoeopathy, Ayurvedic, Unani or any other mode of medical care and treatment.
- (xxvi) To make available mobile medical unit, ambulance, vehicles for carrying patients, dead bodies etc.
- (xxvii) To distribute clothing quilts, blankets, rugs, cottons, used of woolen cloth and other wearing articles to the poor section of the society.
- (xxviii) To arrangement for protection of animals, birds and creatures, to plant trees, arrangement for improvement of seeds and crops.
- (xxix) ***The Trust will never acts which are illegal and unlawful in nature and also oppose to the public policy and contrary to the law of the country for which the trust and the trustees are responsible for that and the whole trust is void and come under the all punishable laws.***
- (xxx) ***The Trust will never acts like Micro financing, Micro credit, Franchise and Money Laundering(Act-2012) economic offence/crime and in nature and shall not obtain any donation or like that from abroad without getting the permission of FCRA ACT from the Central Govt./the competent Govt. authority which the trust and the trustees are responsible for and the, the whole trust is void and come under all punishable laws.***
- (xxxi) ***All aims/ objects/ purpose of the trust herein stated above shall come into effect/ force after necessary approval of the competent Govt. authority in the case where affiliation/ permission/ licence/ sanction is required.***

- (xxxii) **Lawful Purpose:-** A trust may be created for any lawful Purpose. The purpose of a trust is lawful unless it is (a) forbidden by law, or (b) is of such a nature that, if permitted, it would defeat the provisions of any law, or (c) is fraudulent, or, (d) involves or implies injury to the person or property of another, or (e) the court regards it as immoral or opposed to public property. Every trust of which the purpose is unlawful is void. And where a trust is created for two purposes, of which one is lawful and other unlawful, and the two purposes cannot be separated, the whole trust is void.
- (xxxiii) **APPLICATION OF INCOME TAX-** To perform that notwithstanding here in contained in the income as the corpus OF THE TRUST fund the same shall be applicable and applied to the PUBLIC CHARITABLE TRUST PURPOSE ONLY within such territories and subject to such conditions or limitations if any as may from time to time be laid down by the Income Tax Act, 1961 Or Any Other Acts governing taxation of income the wealth of PUBLIC CHARITABLE TRUST so as to render the TRUST hereby established as well as its income eligible for exemption from taxation under such Act or acts, now or prevailing or any modification replacement thereof.
- (xxxiv) To act in such a way that the TRUST hereby established shall always retain the status of one such TRUST no provisions of section 80G/12A/FCRA/35AC/10(23C) IV/V/VIA of the Income Tax Act, 1961 or any modification replacement or there of for the time being in force shall apply so that any donation or contribution there is recognized as eligible for exemption or relief from tax in the hands of the donor provided that such rules and bylaws shall not be inconsistent with or repugnant to any provisions of the scheme of the Trust.
- (xxxv) The Trust shall never borrow and/or augment money from the public or open market by announcing attractive financial investment scheme.
- (xxxvi) All donation and gift from any one individual or institution or any corner shall be accepted by maintaining all legal norms and valid documents / receipts.

As per the constitutional provisions of India there shall be no discrimination on the grounds of race, religion, caste, creed, community or sex in carrying out the objects of the Trust.

6) BOARD OF TRUST:

All the properties of the trust shall remain vested with the Board of trustees (hereinafter referred to as the Board) which shall consists of not less than 2 (Two) trustees and not more than 11 (Eleven) trustees.

The Present Board of Trustees Consist of the Following Persons:

The persons for the time being, constitution the board shall have the power to increase the strength of the board by appointing thereto one or more persons whether on the same occasion or on different occasions as trustees so, however, that the total number of persons constituting the board shall at no time exceed eleven and shall not be less than three. The designation of the trustees may be changed mutually or by vote as situation demands.

In the event of vacancy in the office of the Chairman, the Board shall elect a Chairman amongst themselves. If any of the trustees dies or desires to retire or refuse or become incapacitated to act as a trustee or take to the benefit of the Law of Insolvency, then and in such case there shall be a vacancy in the Board.

Casual vacancy including vacancies created by removal, as stated earlier, may be filled up in the manner aforesaid upon passing of a resolution for appointment of a new trustee by majority of votes and in case of forming a new board of trustees all the properties of the trust will vest upon the newly formed trustees and no formal deed of appointment shall be required to be executed and registered. Vacancies in the Board shall not invalidate any of the proceeding of the Board.

The board may meet as often as necessary and in any event not less than twice in a calendar year. Declaration at the meeting of the board shall be taken by a vote of the majority of the trustees present. In the case of equality of votes chairman of the Board shall have a second or casting vote.

The trustees may from time to time make regulation as to their meeting and the conduct of their business and otherwise as to the management of the affairs of the trust.

A resolution in writing signed by all the trustees, present in India for the time being shall be as valid and effective as if it had been passed at a meeting of the trustees duly called and convened.

The board of trustees may appoint or form executive council or Executive Body or Governing Body for smooth functioning of the organization and the powers and duties, terms and conditions etc. of such executive council shall be determined by the Board of Trust.

6) Power of Trustees:

- i) To collect and receive funds and each fund may be utilized for such purpose for which the same were raised.
- ii) To accept, realize, raise and receive any sum of money by way of gifts, membership, donations, subscription, contribution, thrifts, loans, processing fees, service charge, insurance, etc. from individuals, Self help Groups, etc.
- iii) To acquire movable and property by purchase or otherwise.
- iv) To erect or cause to be erected building or buildings, equipments and machinery for the use, benefit and attainment of the objectives of the Trust.
- v) To manage, administer and control properties and all assets of the trust directly or indirectly and all institutions under or connected with the trust.
- vi) To demand, call for and realize money and other assets due or belongings to the trust and issue receipts and vouchers for the receipts of the same.
- vii) To employ necessary staff for the management, administration of the trust in general and for the institutions in particulars and for the purpose of carrying out the subjects of the trust on such terms as may appear proper to the trustees and to delegate and to allot such staffs from time to time such powers and duties as may be necessary in the useful course of business of the Trust.
- viii) To takeover control and management of any unit or the whole of the Mission/Trust in case of an emergency or any untoward situation, for six months initially and for another six months and to dissolve the executive

council by a resolution of the Board of Trust and to appoint and to appoint Administrator for the management of the Mission.

- ix) The Board of Trust shall have full power to amend, delete or descend it's rules and by law.

To do all acts and things which are connected with the administration of the trust in general and of the institutions of the trust in general and of the institutions in particulars and which are deemed by the trustees to be the best in the interest of the trust and desirable.

- x) The trust is subjected to provide the certification after the successful completion of the study tour and examination which is conducted by this thrust thereof.

7) DUTIES OF THE OFFICE BEARERS:

Chairman:

- i) Shall preside over the meeting of the Trust;
- ii) Take all disciplinary actions such as suspend, removal, dismissal of the employees of the Trust in case of any illegal activity which is contrary of the trust etc. in consultation of the Board of Trust.
- iii) Advice to the Secretary in any matter requiring urgent attention; and
- iv) Call emergent meeting.
- v) Sign and give pay orders on all bills or payments;

Treasurer:

- i) Collect and receipts all sorts of subscriptions, donations and deposit of money and grant receipts thereof;
- ii) Maintain and keep cash book and such other accounts as are necessary.
- iii) Prepare the budget in consultation with the Secretary for consideration of the Board of Trust.

8) NOTICE AND QUORUM:

Seven day's notice of the meeting specifying the place, time and the general nature of work and business to be transacted shall be given to every trustees of the Board of Trust. Emergency meeting may be called on 24 hours notice. Any 1/3rd of the trustees of the Board of Trust personally person shall constitute a quorum for the meeting and if a quorum is not present within 30 minutes of the specified time the trustees present any adjourn the meeting.

9) BENEFICIARY:

The trust is established for the benefit of citizens of India and the class of people mentioned above without discrimination of cast religion or sex, colour or place of birth the general public and community at large (the beneficiaries).

10) DISSOLUTION:

In the Event of dissolution of the trust the entire trust funds shall be realized and first be used for payment of liabilities of the trust, the assets left it any shall be disabused to other trust or association having approval of commission of income tax and in no event it shall be distributed in any manner to any of the bound of trustee or their relations or related persons.

11) AREA OF JURISDICTIONS OF OPERATION:

Area of jurisdiction/operation of the trust in the whole of Indian but preferably in the state of west Bengal and particularly in the limits of Kolkata Municipal Corporation.

12) RENEMURATION OF TRUST:

Area of jurisdiction The trustee will not be able to entitled to receive/get any remuneration as trustee but may reimburse themselves of all expenses actually incurred by them in connection with the trust or their duties thereto subject to passed by the board of resolution and approved by the income tax department.

13) The Settler And The Trustees Can Not Claim Any Ownership Right, Title And Interest Of The Present And Future Trust Property.

14) MEETING:

A meeting of the Board of Trust shall be held as per requirement of the Trust at such place, date, time and agenda as the president or the Secretary may determine. Any 1/3rd trustees of the Board of Trust may requisition the meeting and the Secretary shall summon the same within seven days and falling which the President on the requisition may do so provided no business other than specified in the notice shall be transacted at such meeting.

15) PROCEDURE OF THE MEETING:

The Chairman shall preside over all meetings of the Board of Trust and in his absence, present trustees shall elect a chairman of the meeting. All questions before the meeting will be decided by a majority of votes, each trustee having one vote. The Chairman shall have a 2nd or casting vote in the addition to his own vote in the case of equality of votes.

16) EXPULSION & REMOVAL OF THE TRUSTEES:

A trustee/trustees may be removed from office for misconduct or for obstruction of the functioning of objectives the trust for violation of Rules and Regulation of the Trust by a resolution adopted by two third majorities of the trustees of the board of trust present and voting at a meeting specially called for the purpose. Frequent actions of any trustee, if found by the Board of Trust is detrimental to the interest and is in violation, he may be after the enquiry, censured, suspended or expelled from the trustee by the Board of Trust. In that case, the Board of Trust shall first serve notice upon the trustee with a show cause notice. On receipt of the explanation, the Board of Trust shall have the power to take a suitable action against the delinquent trustee after allowing him to defend his case. If no reply to the show cause notice is received within the stipulated period or any extension of time allowed by the Board of Trust, the Board of Trust may take an expert decision.

For any act of expulsion or termination no such trustee shall be entitled to prefer any claim for compensation or damage even if proved on subsequent date that such act of expulsion or termination was wrongful and/or unlawful. If the aggrieved trustee do so it will not be enforceable before any court of law.

17) RECEIPTS OF CONTRIBUTION ETC. & OPERATION BANK ACCOUNTS:

All contribution to the trust shall be received by any of the trustees of this Board of Trust against a receipt duly signed by the Chairman/Secretary. The fund of the trust will be kept in the custody of the chairman. The trust shall maintain several accounts showing receiving contribution for various heads such as Savings Account/Current Accounts/Fixed Deposit Accounts/Loan Accounts, etc. Every Bank Account shall be opened in the name of the Trust and all such bank Accounts shall be operated jointly by the two trustee, one is Chairman and another is either Secretary or Treasurer time to time decided by the Board of Trust. Separate account or accounts may be opened in the name of Trust or in compliance to some provisions of law, rules, regulation and by-laws requiring

opening of such bank accounts, the manner of operation of such account or accounts shall be decided by the Board of Trust by way of passing appropriate resolution in that effect.

18) ACCOUNTS AND AUDIT:

The board will kept the accounts of the trust on accrual basis and close at the end of March in each Financial Year. Chartered Accountant or a Firm of Chartered Accountants appointed by the Board of Trust shall audit the accounts of the Trust. The audited accounts of the trust shall be adopted at a meeting of the Board of Trust called for the purpose.

19) ALLOWANCES TO TRUSTEES OR OFFICE BEARERS:

If at any time any trustee acts as a whole time office bearer of the Trust, or renders any special service, the trust may in its discretion pay such remuneration or allowance to such trustee, as it may deem fit and proper.

20) POWER TO MAKE OVER TRUST FUNDS:

If at any time all the trustees of the trust do not desire to remain trustees or to manage the affairs of the trust, they shall be entitled to appoint any bank undertaking for the execution of trust business either along with or in conjunction with any or the trustees or any other persons whom the trust managing and dealing with the trust estate or property in terms of this deed and on such terms as to remuneration or otherwise as they may think fit or in the alternative the trustees shall be at liberty to make over the trust funds or any part thereof to any institution of trust formed for all any one or more of the objects for which this trust has been created to hold and to carry out the objectives of the trust and to deal with same. According to the provisions hereof the said trustees shall after making over the trust estate and/or the foundation properties to such trustees be completely absolved from any responsibility hereunder.

21) SUITS AND LEGAL PROCEEDINGS:

The board may sue or be sued in the name of the Secretary or the Chairman. The board may, by a resolution passed specially or generally at any time to time or from time to time authorize any of the trustees by power of attorney or otherwise to represent and to contest suit or legal proceeding of the trust.

- i) To institute, conduct, defend, compound, withdraw, compromise, give consent to arbitration in any suit or legal proceeding in favor of the trust compromise petition etc. On behalf of the trust.
- ii) In entering in any agreement or contract which appear to be beneficial to the trust.

22) FINANCIAL YEAR:

The financial year of the trust shall be a period starting from 1st April and ends on 31st March.

23) BOOKS OF ACCOUNTS & INSPECTIONS:

The books of account and other statutory books shall be kept at the registered office and shall open for the inspection of the trustees at such time and place as the Board directs on a written request made by any trustee.

24) WINDING UP OF THE TRUST:

The trust is IRREVOCABLE. If uneventful event may arise that the trust is not possible to run then the property, funds and assets of the trust there may remain after full settlement of the liabilities of the trust, will be transferred, paid and handed over to any other Trust, society or Institution established for achieving similar aims and objectives and having registration u/s. 12A and eligibility u/s. 80G of the Income Tax Act, 1961. If such types of Trust, Society or Institutions are not available, then the entire property of the Trust shall be vested upon the Government.

Provided that-

- i) Notice of such meeting is to be served on all the existing trustees,
- ii) Such meeting is to be attended by 3/4th of the existing trustees,
- iii) Such decision or a resolution is to be carried by the votes of at least 3/4th of the trustees present in the meeting.

25) AMENDMENTS TO THE SCHEME

If any time it is found that alterations in any of the provision of the trust or scheme for the purpose of effective achievement of the object of the trust are imperative and very essential, then the board shall approve such alteration by a resolution passed in its meeting and thereafter the

modification shall become part and parcel of the terms, condition and provisions of this trust and of this scheme.

The board may at any time and from time to time make, amend, delete and resend rules and bylaws for the conduct of this business, for the control, management and administration of the trust made under this trust deed and for carrying out the objects of the trust relating to any matter under the scheme, provided that such rules and bylaws shall not be inconsistent with or repugnant to any provisions of the scheme of the trust.

26) REGULATION AND BYE LAWS:

The trustees shall be entitled to frame, modify, amend, alter or repeal rules and bye-laws for the purpose of administering the trust and /or its institutions provided that in the event of any inconsistency or conflict in such rules/bye laws, the rules and bye-laws framed, modified, amended, altered or repealed by the Board shall prevail.

Subject to what is stated in this deed any of the above terms of this deed may be amended, altered or modified by a majority of two third member of the Board present in a meeting called for this purpose. Provided however, that no amendment contrary to the objection of the foundation herein before set forth shall be valid and effective. If any of the objectives of the foundation be found contrary to the provisions of the I.T. Act For the time being in force then the trustees shall have the power to make necessary amendment in any of the object, clause to comply with the provisions of Income Tax Act, 1961 by passing resolution by majority of votes.

APPLICABILITY OF TRUST ACT-1882---THE PROVISIONS OF THE INDIAN TRUST ACT 1882 SHALL APPLY TO ALL MATTERS NOT SPECIALLY MENTIONED IN THESE PRESENTS violating the same in any part, the whole trust is void.

27) DECLARATION:

The trust and scheme set forth under this indentures shall come into force immediately after the execution thereof:

The Trustees above named hereby constitute the trust and declare that they have consented to the trustees under this trust, accept the trust and have taken delivery of the possession demure and defector of the schedule fund of

price of and that in witness where of, they off, they, the trustees above named as parties thereto have affixed their signatures hereunder.

SCHEDULE

At present this Trust has no property either movable or immovable except trust fund of Rs. 10,000/- (Rupees Ten Thousand only).
